Important Information on Contractor Registration

1. Failure to submit this Prescribed Booth Design & Construction Contractor's Registration form will result in non-issue of Booth Construction Permission by the organisers, without which your contractor will not be allowed to enter HGH India premises and start your booth construction.
2. Please refer **exhibitor check-in / check-out schedule on page no. 5** of the Exhibitor's Manual, for booth Set up & dismantling timings. Work beyond these timings will amount to delay and will attract penalties prescribed for late completion of booth.
3. Please take the possession of your booth in time as listed. If you take late possession of your booth, you will not be allowed extra time to complete the same.
4. The contractor should finish all booth construction activities like structure, woodwork, painting and finishing by **12:00 noon on 12th December, 2023**, after which these activities will not be allowed. No major carpentry work, spray paint and polish work will be allowed at the venue at any time. Contractors must bring prefabricated structure and give only assembly and finishing touches at the venue. They must complete electrical, graphics and product display work by **10:00 pm on 12th December, 2023**.
5. After the above timings, a penalty of **₹ 10,000/-** per hour, per booth for the work carried out after the above mentioned deadlines would be applicable.
6. Please refer to **page no. 7, 8, 9 & 10** of this Exhibitors Manual for the Booth Design & Construction guidelines.
7. A Damage & Performance Bond (Refundable Security deposit - This security deposit will be refunded after 30 days after completion of HGH India 2023) of **₹ 25,000/-** per booth for area up to 50 sq. mtrs. and **₹ 50,000/-** per booth for area above 50 sq. mtrs. is to be paid by the appointed Booth Contractor along with the design submitted for approval through Cheque / demand draft favouring **"Texzone Information Services Pvt. Ltd."** payable at Mumbai.
8. Any damage to the venue property, carpet or electrical fittings by the exhibitors/ contractors or penalties applicable, if any, will be charged to your account by the onsite organiser officials and will be deducted from the security deposit.
9. Exhibitors have to submit a **"Stability Certificate"** from a Government approved Structural Engineer for the Mezzanine structure being created. Copies of the same must be submitted to the organiser before the design can be app
